

## FY17 Annual Report

### DOMESTIC VIOLENCE SHELTER

Our shelter provided safe sanctuary & hot meals for 881 neighbors who escaped from violence. Half were children. On average, we care for 109 people each night of the year.



### VICTIM ASSISTANCE LEGAL REPRESENTATION

Dedicated staff & volunteers accompanied more than 5,000 victims to court to obtain a Domestic Violence Protective Order. Attorneys represented 382 neighbors seeking protective orders against their abuser.



### SEXUAL TRAUMA RESOURCE CENTER

We provided 1,929 trauma counseling sessions to adult & child victims of sexual assault. We also accompanied 100 sexual assault victims to the hospital.

To this end we work in alliance with our clients, other organizations, and the broader community toward achieving our vision of building communities where people are empowered to grow and sustain healthy and respectful relationships, and in which we, together, actively work against the systems and beliefs that sustain poverty, racism, and gender-based violence.

### In Our Backyard

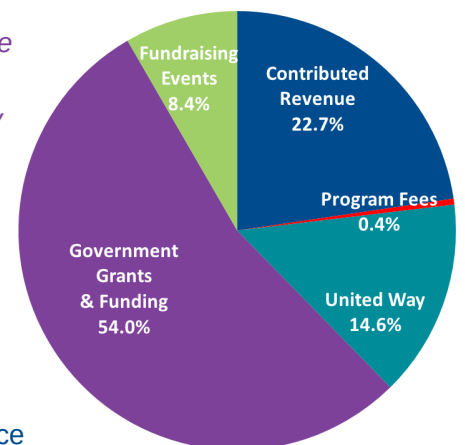
- CMPD responded to more than 35,000 domestic violence-related calls last year.
- 1 in every 4 girls and 1 in every 6 boys will be sexually assaulted before their 18th birthday.
- 1 in 3 women will be impacted by sexual assault or domestic violence during their life time.

97%

Clients experienced an increase in their personal safety after receiving protective order & court accompaniment services from Victim Assistance.

99%

Children served at the Shelter had an increase in their pro-social behavior.

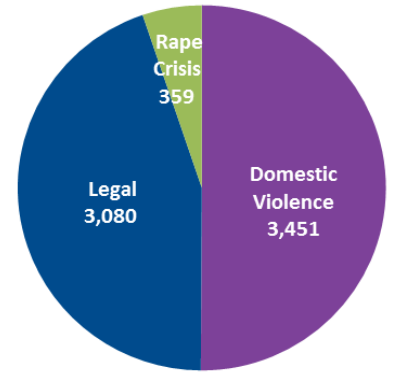
96%
