EACH YEAR, SAFE ALLIANCE SERVES OVER 7,000 PEOPLE THROUGH OUR IN-PERSON SERVICES; 9,000 PEOPLE THROUGH OUR 24/7 CRISIS LINES, AND AN ADDITIONAL 6,000 THROUGH OUR EDUCATION, PREVENTION AND INSTITUTIONAL ADVOCACY EFFORTS. IN FY18, SAFE ALLIANCE'S DOMESTIC VIOLENCE SHELTER OFFERED SAFE HAVEN TO 934 DOMESTIC VIOLENCE VICTIMS AND THEIR DEPENDENT CHILDREN WHO WERE IN IMMINENT DANGER. 83% OF SHELTER RESIDENTS WHO STAYED TWO OR MORE WEEKS EXITED TO SAFE HOUSING. 95% LEARNED NEW STRATEGIES TO REMAIN SAFE.
